### **School Description and Mission Statement (School Year 2012-13)**

This section provides information about the school, its programs and its goals.

Savanna High School is a proud community of dedicated staff, involved parents, and empowered students whose members are engaged in academic excellence and are called to develop purposeful lives.

The mission of Savanna High School is to develop productive members of society who actively pursue the fulfillment of their potential. Our students will demonstrate competence in academic, personal, occupational, and citizenship skills. We will strive to prepare our students for lifelong learning, working, and contributing to our community, state, nation, and world.

Savanna High School, located in West Anaheim, California, serves 2,123 students, in which 68% participate in the free and reduced meal program, 35% are English Learners, and 10% are Students with Disabilities. The demographic profile also indicates the following regarding student subgroups: 71% Hispanic; 12% White; 7% Asian; 5% African American; 4% Filipino; and, 1% Pacific Islander. These students are served by a staff of 92 teachers, four administrators, four counselors, and 40 classified support staff. Moreover, Savanna offers numerous Advanced Placement courses, including English Language and Composition, English Literature and Composition, European History, United States History, Government, Statistics, Calculus, Biology, Physics, Spanish Language, Spanish Literature, and Studio Art.

Savanna High School students are developing P-21 skills to ensure that they are college and career ready. Each student is placed in one of our Career and Technical Education (CTE) Pathways. Each CTE Pathway gives students and parents the opportunity to prepare for graduation and beyond. Class sequence, elective offerings, college requirements, and certification opportunities are embedded in each CTE Pathway.

#### **Highlights from the SPSA Action Plan to Address Student Achievement Issues**

Savanna High School teachers are implementing the following: critical reading strategies, “writing to learn” strategies, and “accountable talk”, and AVID strategies school wide. Teacher collaboration meetings and release days happen regularly to review data, refine teaching practice, and identify best practices to ensure that the students are college and career ready.

## Opportunities for Parental Involvement (School Year 2012-13)

Savanna High School strives to be a collaborative school environment, offering all stakeholders the opportunity to be involved in student learning and success. Parents are encouraged to participate through a variety of avenues, including: participating in PTSA, attending parent workshops for student success hosted by the Title I Specialist, Community Liaison and the Principal; attending quarterly "Coffee with Counselors" hosted by the counselors; attending college nights hosted by the counselors; participating in booster organizations, attending award assemblies; attending Back to School Night and Open House. Parents have opportunities to receive assistance in accessing Aeries parent information taught by counselors. The PTSA annually awards scholarships to senior students. Counseling hosts events for Honors/AP students and organizes the Rebel Awards. Parents and community participate in school-wide events, including Red Ribbon Week and International Day. A full-time community liaison was hired in 2009 and coordinates with the full-time Title I Specialist to assist families.

## III. Student Performance

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- **California Standards Tests (CSTs)**, which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- **California Modified Assessment (CMA)**, an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- **California Alternate Performance Assessment (CAPA)**, includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

The most important adjustment/ update was made to the emergency lock-down procedures where we adopted the Anaheim City's 3 phase procedure. Staff was instructed by city police on the current process/ procedures during an emergency lock-down. Evacuation processes were updated to provide a more efficient clearing of our campus during disaster drills. We also now include our Medical Academy students in the search and rescue procedures during disaster evacuations.

Savanna High School opened in 1961. Savanna is one of nine comprehensive high schools in the Anaheim Union High School District, serving West Anaheim, parts of Buena Park, and some unincorporated areas of Orange County. The 41.8 acre site includes 63 regular classrooms and 13 portable classroom buildings. There are 19 labs, which are designed for specific programs (i.e. computer labs, science labs, choral music room, etc.) The site also includes an auditorium, a cafeteria, a library, a gym and pool facility, and a variety of sports fields.

**Maintenance and Repair:** Site and District maintenance staff ensure that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service. Emergency repairs are given the highest priority.

**Cleaning Process and Schedule:** The District's Board of Trustees has adopted cleaning standards for all schools. The administration works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school. All classrooms and restrooms are cleaned daily. Deep cleaning, including waxing of floors and painting, takes place during times when students are not in classes. Students, parents, and staff are encouraged to report any objectionable conditions via a uniform complaint procedure.

The most recent site inspection (Williams Facilities Review) was completed on November 15, 2013.

#### University of California

Admission requirements for the University of California (UC) follow guidelines set forth in the Master Plan, which requires that the top one-eighth of the state's high school graduates, as well as those transfer students who have successfully completed specified college course work, be eligible for admission to the UC. These requirements are designed to ensure that all eligible students are adequately prepared for University-level work.

#### California State University

Eligibility for admission to the California State University (CSU) is determined by three factors:

- Specific high school courses
- Grades in specified courses and test scores
- Graduation from high school

Some campuses have higher standards for particular majors or students who live outside the local campus area. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. ## **XII. Instructional Planning and Scheduling**

### **Professional Development**

Teachers participate in a variety of District in-services as well as professional development workshops and conferences to enhance their content knowledge and instructional skills. New teachers are also required to participate in the Beginning Teacher Support and Assessment (BTSA) program. The District and school continue to train teachers in strategies to deliver a differentiated curriculum with depth and complexity utilizing teacher coaches who are referred to as Lesson Design Specialists (LDS). Teachers learn to utilize students' assessment results in order to target instruction to better meet the individual needs of students. Teachers select professional development areas to work in and meet in those areas several times over the course of the school year. Weekly late-start days have allowed for greater collaboration between and within departments. Title I funds have allowed English and mathematics departments to develop strategic plans to enhance student achievement. Classified staff members have many opportunities to participate in training designed to enhance their effectiveness with students. All District staff members are supported in their efforts to deliver highly-effective lessons.
